## Wisconsin Firearm Owners at the State Capitol



There has been a flurry of activity behind the scenes at the State Capitol as the legislature's 2 year session cycle starts winding down. Association President Rob Kovach attended and testified at the public hearing for Senate Bill 822: an important bill that clarifies that places of worship that are part of a complex that involves a school are not prohibited

from the concealed carry law. While current law allows concealed carry in these places of worship, it isn't perfectly clear that these complexes that include a school aren't part of a gun-free school zone and SB-822 clarifies the law on that.

Because perpetrators of mass violence almost always choose "gun-free" zones to attack, making this change will hopefully discourage attackers from choosing places of worship.

Another bill that the Association worked on for our members that was just signed into law was Assembly Bill 75. This bill ensures that municipalities can't ban ceremonial gun salutes with blanks. Some municipalities were unsure if firing blanks in a ceremonial display would violate their laws against the discharge of firearms within their municipal limits. WFO Board Member Victoria LaBrosse and WFO Lobbyist Bob Welch were in attendance for the signing.



By being present at the Capitol and by developing relationships with the legislators and their staff across the state, your Association is doing its best to advance issues that are important to you and it helps us communicate with them when a proposal that hurts our gun freedoms so those measures don't advance.

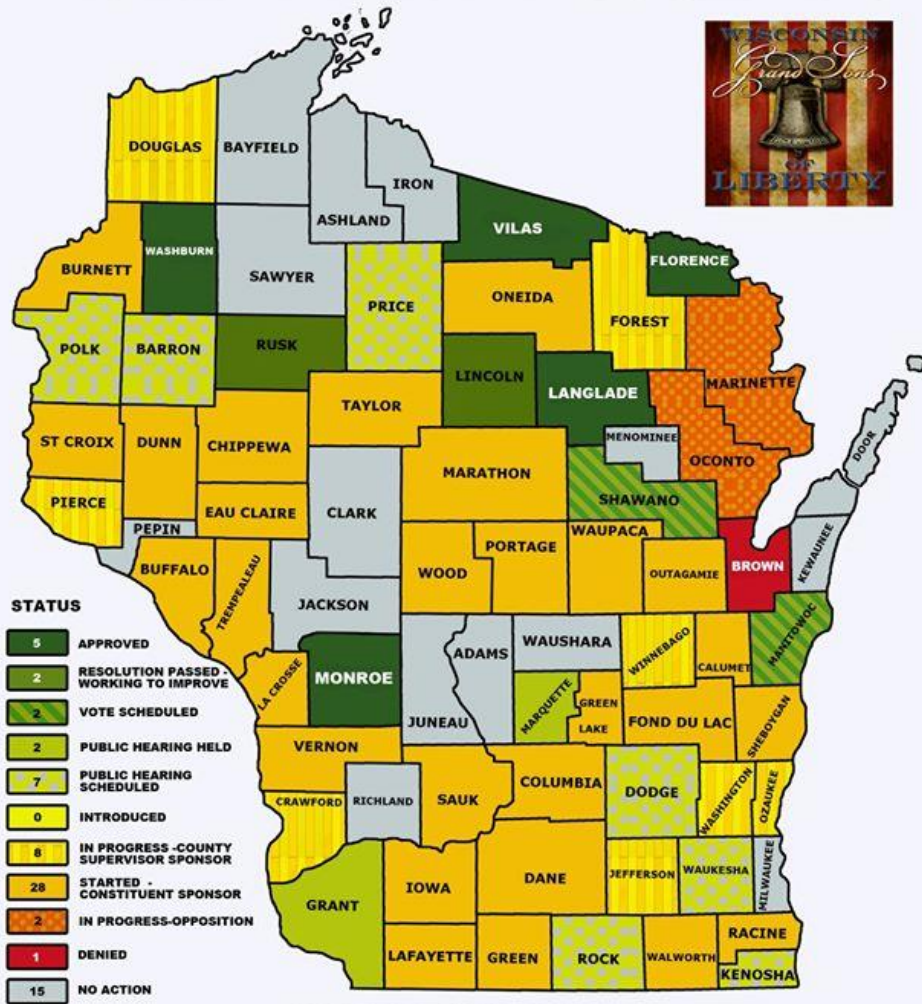
# Second Amendment Counties

# Milwaukee County Second Amendment Restrictions

**If you live in Milwaukee County you need to take action on this Resolution. Please read the information provided below and attend and county meeting pertaining to this Resolution.**

---

Thank you for considering attending the March 17<sup>th</sup> Milwaukee County Parks, Energy, and Environment meeting to voice your support to continue holding the gun show at the Milwaukee County Sports Complex. The committee meeting will be held at 12:00 PM in Room 201-B of the County Courthouse (901 N. 9<sup>th</sup> Street, Milwaukee, WI 53233).

There are two entrances to the courthouse. They are located about halfway into 10<sup>th</sup> and 9<sup>th</sup> Street. The 10<sup>th</sup> Street entrance tends to be less congested in my experience.

For parking, there a few different options:

- The MacArthur Square parking lot is the closest to the Courthouse but also the most expensive. It provides an underground tunnel from the lot to the 9<sup>th</sup> Street entrance
- The Fiserv Forum/Interstate Parking Lot is cheaper, but it requires walking a few blocks
- The Wells Street Parking Lot (kitty-corner to the Public Museum) is the cheapest one I know of, but this too requires walking a few blocks
- I've attached a map for your convenience. MATC is listed on there, but I have never had visitors use that one

When you arrive, you will need to go through security. Please make sure to leave any weapons in your vehicle. Once you are through security, proceed to the second floor and find Room 201. Once inside Room 201, immediately to the right is Room 201-B, which is the room the Parks committee will use.

At this time, it looks like Supervisor Logsdon's resolution will be agenda item 3. Once the item is before the committee, Supervisors will hear from the presenting Supervisor and any staff that wants to comment or provide information to the committee. After this, then members of the public will have the opportunity to speak on behalf of an item.

To speak, you will need to fill out a blue card provided by the Committee Clerk. That card will ask for basic information (name, etc.), whether you are for or against the item, and whether you would like to speak to the committee. Speakers are given 2 minutes per person. Don't worry if you can't remember all of this. The committee clerk and chairperson always remind people of these procedures at the meeting.

Feel free to forward this information along to whomever you think might be interested.

## **A RESOLUTION/ORDINANCE**

Amending Chapter 63 of the Milwaukee County Code of General Ordinances relating to carrying firearms or other dangerous weapons in county buildings to permit facility rentals for gun shows

WHEREAS, the Milwaukee County Code of General Ordinances Chapter 63.016 outlines the rules and regulations for the carrying of firearms and other dangerous weapons in county buildings; and

WHEREAS, the ordinance prohibits the carrying of concealed or unconcealed weapons in any part of a building that is owned, occupied, or controlled by Milwaukee County; and

WHEREAS, the ordinance does not make exceptions for gun shows, which are events dedicated to the display and legal sale of firearms and firearm-related accessories; and

WHEREAS, the Milwaukee County Sports Complex in Franklin is home to the biannual Milwaukee County gun show; and

WHEREAS, the Milwaukee County gun show is hosted by the Wisconsin-based Take a Kid Hunting Foundation, which is a 501(c)(3) non-profit organization that benefits youth and disabled veterans; and

WHEREAS, the Milwaukee County Department of Parks, Recreation, and Culture advised the event organizers that the gun show could no longer be held at the Milwaukee County Sports Complex because it violated Chapter 63.016 of the Milwaukee County Code of General Ordinances; and

WHEREAS, in 2019, the State of Wisconsin Department of Natural Resources (DNR) reported that 564,664 gun deer licenses were sold through the end of the nineday gun deer season; and

WHEREAS, the DNR classifies Milwaukee County as part of the Southern Farmland Zone for the purposes of deer harvest recordings, which recorded 36,782 antlered and antlerless deer registrations for the 2019 season, which is the second highest registration total of all four zones; and

WHEREAS, gun shows provide knowledge and opportunities for the community to learn more about sport hunting, which is a popular hobby pursuit in Milwaukee County and throughout Wisconsin; and

WHEREAS, the Milwaukee County Code of General Ordinances should reflect this through the allowance of gun shows in county buildings; now, therefore,

BE IT RESOLVED, that the Milwaukee County Board of Supervisors hereby amends Chapter 63.016 of the Milwaukee County Code of General Ordinances by adoption of the following:

### **AN ORDINANCE**

The Milwaukee County Board of Supervisors does ordain as follows:

**Section 1.** Chapter 63.016 of the Milwaukee County Code of General Ordinances is hereby amended as follows:

**63.016. – Carrying firearm or other dangerous weapon in county building.**

- (1) It shall be unlawful for any person carrying a concealed or unconcealed dangerous weapon as defined in s. 939.22(10), Wis. Stats. to enter or remain in any part of a building that is owned, occupied or controlled by Milwaukee County.
- (2) To provide notice of the prohibition stated in subsection (1) as required under ss. 943.13(1m)(c)4. and 943.12(2)(bm), Wis. Stats., the director of transportation and public works and any other Milwaukee County administrator having management and control of a building or part of a building that is owned, occupied or controlled by Milwaukee County shall post or cause to be posted signs informing the public that firearms and other dangerous weapons are forbidden in Milwaukee County buildings and that entering or remaining in a Milwaukee County building while carrying a concealed weapon is a violation of s. 943.13(1m)(c), Wis. Stats., and Milwaukee County Ordinances. Such signs shall be at least five (5) inches by seven (7) inches and shall be posted in prominent places near all entrances to all such buildings or parts of any buildings in locations where an individual entering the building can be reasonably expected to see the signs.
- (3) This section does not apply to a person who leases residential or business premises in a building owned by Milwaukee County or, if the dangerous weapon is a firearm and the firearm is in a vehicle driven or parked in the parking facility, to any part of the building used as a parking facility.
- (4) This section does not apply to a building or portion of a building as described in s. 175.60(16)(a), Wis. Stats.
- (5) This section does not apply to a building or portion of a building that is being rented for the purposes of a gun show, with gun show being defined as an event dedicated to the display and sale of firearms and firearmrelated accessories.



# Virginia gun safety bills head to Democratic governor for signature

Washington (CNN)A group of gun safety bills in Virginia are headed to the governor's desk for his signature after passing the state General Assembly in recent days, the last hurdle in a series of legislative steps needed to finalize the measures into law.

The bills, part of a bundle of policies known as the "[Governor's Package](#)" that represents a number of Democratic Gov. Ralph Northam's priorities, have steadily advanced through the Democrat-controlled state legislature in the 2020 legislative session.

The eight bills advancing for Northam's approval include measures to extend firearm prohibitions for those under protective orders, require citizens to report lost or stolen weapons, allow local governments to have more authority to enact gun laws in their localities, update protections to keep unsecured weapons out of the hands of children and teens and to create a "[red flag law](#)."

Also known as an extreme risk protective order, the so-called red flag law would create a procedure for authorities, including law enforcement officers and attorneys, to apply for an emergency substantial risk order to prohibit "a person who poses a substantial risk of injury to himself or others from purchasing, possessing, or transporting a firearm." Under the proposal, if such an order is issued, a judge or magistrate can issue a search warrant to remove firearms from that person.

Northam in a recent tweet applauded the passage of the bills, which he is expected to sign.

Pro-gun safety organizations like Brady: United Against Gun Violence, touted the passage as "enacting the will of the people and making Virginia safer." One of the measures advancing to Northam has been implemented in 17 states and Washington, DC, according to the Brady organization which is still pushing for the final bills to pass this year.

Democratic lawmakers have been locked in a battle with conservatives and Republican lawmakers alike over gun regulation in the state. In mid-February, Virginia lawmakers, led by Republicans, were able to [halt a bill](#) in a Senate committee that would have banned assault weapons.

State Sen. Mark Obenshain, a Republican and the ranking member on the state Senate Judiciary Committee, told CNN at that time that "although we have been able to defeat some of the most sweeping and egregious bills, the Democrats have made clear that they intend to press forward with their agenda to gut the protections afforded by the Second Amendment."

A "[Second Amendment sanctuary](#)" movement also recently swept through conservative counties, culminating in a massive but peaceful gun rights rally in late January. Pro-gun groups like the Virginia Citizens Defense League claim the gun safety measures infringe upon the right to bear arms by "law abiding citizens."

Philip Van Cleave, VCDL's President has opposed the Democratic efforts and told CNN that the group would challenge the measures in court if they were passed into law. Cleave also noted that nearly all the statewide elected positions are up for reelection come 2021 including the governorship, lieutenant governorship, attorney general and the entire House of Delegates.

"We are going to be challenging a couple of things. ... We are going to be looking at any of the bills that infringe on our rights," Cleave said.

Four bills in the House and Senate that would expand background checks and limit the purchase of handguns to one a month are under consideration by representatives from both chambers who are working to agree on final parameters of the legislation. Those measures are part of the "Governor's Package" but would still need passage from both chambers to advance to the governor's desk.
